THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CALLING FOR THE CREATION AND EXTENSION OF CERTAIN POOLS IN SAN JUAN AND RIO ARRIBA COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 19, 1956, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this <u>definition</u> day of February, 1956, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

1. That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

2. That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of gas from the Farmington formation, said pool to bear the designation Kutz-Farmington Gas Pool. Said Kutz-Farmington Gas Pool was discovered by R & G Drilling Company, R & G #11, located NE/4 SW/4, Section 28, Township 28 North, Range 11 West, NMPM. It was completed October 7, 1955.

3. That there is need for certain extensions to the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, and the Fulcher Kutz-Pictured Cliffs Pool and the West Kutz-Pictured Cliffs, both in San Juan County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in San Juan County, New Mexico, classified as a gas pool for Farmington production, be and the same is hereby created and designated as the Kutz-Farmington Gas Pool, consisting of the following described acreage: -2-Order No. R-746

(b) That the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:

(c) That the Fulcher Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:

TOWNSHIP 29 NORTH, RANGE 12 WEST, NMPMSection 1:W/2 and SE/4

(d) That the West Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:
