#### ORDER OF THE COMMISSION

# BY THE COMMISSION:

This cause was reopened and came on for hearing at 9:00 a.m. on September 12, 1984, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>30th</u> day of October, 1984, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

### FINDS THAT:

(1) Due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) Case No. 8134 was originally heard before the Commission on July 17, 1984, and Division Order No. R-7634 was issued pursuant to that hearing.

(3) Said Case No. 8134 is being reopened at this time at the request of the applicant, Ladd Petroleum Corporation, to consider an exemption to the pricing provisions of the New Mexico Natural Gas Pricing Act, hereinafter referred to as the "Act" for the applicant's Ladd Petroleum Corporation Knauff "B" Well No. 1-E located 820 feet from the South line and 1660 feet from the West line (Unit N) of Section 31, Township 28 North, Range 10 West, NMPM, Basin-Dakota Pool, San Juan County, New Mexico.

(4) At the time of the hearing the applicant requested that the application for an exemption from the "Act" for the above described well be <u>dismissed</u>.

(2) Jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
