ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 10 o'clock a.m. on April 3, 1956 at Hobbs, New Mexico, before Warren W. Mankin, Examiner duly appointed by the Oil Conservation Commission of New Mexico in accordance with Rule 1214 of the Rules and Regulations of the New Mexico Oil Conservation Commission.

NOW, on this 18th day of June 1956, the Commission, a quorum being present, having considered the application, the evidence adduced, the recommendations of the Examiner, Warren W. Mankin, and being fully advised in the premises,

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That due to the faulted condition of the pool, applicant will be deprived of its fair share of oil and gas in the Bagley-Siluro-Devonian Pool unless he is allowed to drill the unorthodox location as requested.

(3) That there were no objections entered to the granting of this application.

IT IS THEREFORE ORDERED:

The application of Sunray Mid-Continent Oil Company


