## ORDER OF THE DIVISION

## BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on January 6, 1988, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this <u>llth</u> day of January, 1988, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the contraction of the Otero-Gallup Oil Pool in Rio Arriba County, New Mexico, in order that the deleted acreage may be placed in the West Lindrith Gallup-Dakota Oil Pool in Rio Arriba and Sandoval Counties, New Mexico.

(3) There is need for the dismissal of the proposed extension to the Gavilan-Mancos Oil Pool in Rio Arriba County, New Mexico.

(4) There is need for certain extensions to the Aztec-Pictured Cliffs Pool, the South Bisti-Gallup Oil Pool, the Bisti-Lower Gallup Oil Pool, and the Fulcher Kutz-Pictured Cliffs Pool, all in San Juan County, New Mexico, and the Blanco-Pictured Cliffs Pool and the Otero-Chacra Pool in Rio Arriba and San Juan Counties, New Mexico, and the -2-Case No. 9292 Order No. R-8585

Devil's Fork-Gallup Associated Pool, the Northeast Ojito Gallup-Dakota Oil Pool, and the Wildhorse-Gallup Pool, all in Rio Arriba County, New Mexico, and the West Lindrith Gallup-Dakota Oil Pool and the Lybrook-Gallup Oil Pool in Rio Arriba and Sandoval Counties, New Mexico, and the Nose Rock-Hospah Oil Pool in McKinley County, New Mexico, and the Otero-Sanastee Oil Pool and the Rio Puerco-Mancos Oil Pool, both in Sandoval County, New Mexico.

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a nonstandard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the -6-Case No. 9292 Order No. R-8585

same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division shall subject the well to cancellation of allowable.

(2) The effective date of this order and all contractions and extensions included herein shall be February 1, 1988.
