ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 17, 1956, at Santa Fe, New Mexico, before the Oil Con-servation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this $\cancel{3}$ day of November, 1956, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool, the Otero-Pictured Cliffs Pool and the South Blanco-Dakota Pool, all in Rio Arriba County, New Mexico, the Bisti-Lower Gallup Oil Pool in San Juan County, New Mexico, and the South Blanco-Pictured Cliffs Pool, the Ballard-Pictured Cliffs Pool, and the Blanco Mesaverde Pool, all in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:
