THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on September 5, 1991, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this <u>10th</u> day of September, 1991, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Canyon formation, said pool to bear the designation of Frontier Hills-Upper Pennsylvanian Gas Pool. Said Frontier Hills-Upper Pennsylvanian Gas Pool was discovered by the Pacific Enterprises Oil Company PEOC 15 State Well No. 1 located in Unit L of Section 15, Township 23 South, Range 26 East, NMPM. It was completed in the Canyon formation on March 12, 1991. The top of the perforations is at 10,178 feet.

(3) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Pennsylvanian formation, said pool to bear the designation of North Newmill-Pennsylvanian Gas Pool. Said -2-Case No. 10382 Order No. R-9578

North Newmill-Pennsylvanian Gas Pool was discovered by the Robert J. Mannes State 35 Well No. 1 located in Unit J of Section 35, Township 3 South, Range 27 East, NMPM. It was completed in the Pennsylvanian formation on July 18, 1990. The top of the perforations is at 6,350 feet.

(4) There is need for certain extensions to the Buffalo Valley-Pennsylvanian Gas Pool and the South Palma Mesa-Pennsylvanian Gas Pool, both in Chaves County, New Mexico, and the East Burton Flat-Strawn Gas Pool, the Cabin Lake-Delaware Pool, the South Carlsbad-Morrow Gas Pool, the East Catclaw Draw-Delaware Pool, the South Culebra Bluff-Atoka Gas Pool, the North Dagger Draw-Upper Pennsylvanian Pool, the South Dagger Draw-Upper Pennsylvanian Associated Pool, the Diamond Mound-Morrow Gas Pool, the Fadeaway Ridge-Delaware Pool, the Grayburg-Morrow Gas Pool, the Ingle Wells-Delaware Pool, the Kennedy Farms-Morrow Gas Pool, the East Loving-Delaware Pool, and the Walters Lake-Bone Spring Pool, all in Eddy County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico, classified as a gas pool for Canyon production is hereby created and designated as the Frontier Hills-Upper Pennsylvanian Gas Pool, consisting of the following described area:

TOWNSHIP 23 SOUTH, RANGE 26 EAST, NMPM Section 15: W/2

(b) A new pool in Chaves County, New Mexico, classified as a gas pool for Pennsylvanian production is hereby created and designated as the North Newmill-Pennsylvanian Gas Pool, consisting of the following described area:

TOWNSHIP 3 SOUTH, RANGE 27 EAST, NMPM Section 35: E/2

(c) The Buffalo Valley-Pennsylvanian Gas Pool in Chaves County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 15 SOUTH, RANGE 27 EAST, NMPM Section 14: N/2 Section 15: E/2 -3-Case No. 10382 Order No. R-9578

(d) The East Burton Flat-Strawn Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

> TOWNSHIP 20 SOUTH, RANGE 30 EAST, NMPM Section 6: W/2

(e) The Cabin Lake-Delaware Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(f) The South Carlsbad-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(g) The East Catclaw Draw-Delaware Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(h) The South Culebra Bluff-Atoka Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(i) The North Dagger Draw-Upper Pennsylvanian Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(k) The Diamond Mound-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(1) The Fadeaway Ridge-Delaware Pool in Eddy County, New Mexico as heretofore classified, defined, and described, is hereby extended to include therein:

(m) The Grayburg-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(n) The Ingle Wells-Delaware Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(0) The Kennedy Farms-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(q) The South Palma Mesa-Pennsylvanian Gas Pool in Chaves County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

> TOWNSHIP 8 SOUTH, RANGE 27 EAST, NMPM Section 29: All

(r) The Walters Lake-Bone Spring Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

> TOWNSHIP 18 SOUTH, RANGE 30 EAST, NMPM Section 2: SW/4 Section 3: S/2

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations and extensions included herein shall be October 1, 1991.
