APPLICATION OF GULF OIL CORPORATION FOR AN ORDER ESTABLISHING A 234-ACRE NON-STANDARD GAS PRORATION UNIT IN THE EUMONT GAS POOL, LEA COUNTY, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 23, 1957, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner, duly appointed by the Oil Conservation Commission, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 10^{49} day of May, 1957, the Commission, a quorum being present, having considered the application, the evidence adduced, the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That the applicant is the owner of the E/2 SW/4 of Section 6 and the NW/4 Section 7, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

(3) That the applicant is the owner and operator of the H. T. Mattern "D" Well No. 6, located 660 feet from the South line and 1980 feet from the West line of said Section 6.

(4) That the applicant proposes to form a 234-acre nonstandard gas proration unit in the Eumont Gas Pool consisting of the above-described acreage to be dedicated to the aforementioned H. T. Mattern "D" Well No. 6.

(5) That the establishment of the proposed non-standard gas proration unit will not cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Gulf Oil Corporation for the establishment of a 234-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the E/2 SW/4 of Section 6 and the NW/4 of Section 7, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico, be and the same is hereby granted, and that the applicant's H. T. Mattern "D" Well No. 6, located 660 feet from the -2-Case No. 1241 Order No. R-997

South line and 1980 feet from the West line of said Section 6, be and the same is hereby designated as the unit well for the unit.

(2) That the aforementioned H. T. Mattern "D" Well No. 6, be granted an allowable in the proportion that the acreage in the above-described unit bears to a standard proration unit for the Eumont Gas Pool subject to the provisions of Rule 8 of the Special Rules and Regulations for the Eumont Gas Pool as set forth in Order No. R-520.
