All producing wells on location were immediately shut in. The fire department was notified and extinguished the fire. The amounts released/lost are uncertain due to the fire itself. We believe the numbers to be ~4 bbls of oil and ~8 bbls of produced water, and we recovered the free standing liquid with a vac truck. The fire obviously consumed an unknown portion. Incident is under further investigation.
