Truck was emptying an oil tank and transferring to another one. Provider loaded truck and while waiting, worked on a check valve, opening a 1" valve that had hose going into sump to check for trapped pressure. Set truck to start blowing back to next oil tank. Checked check valve for leaks but did not notice oil filling the sump at the time. Provider did not notice issue while truck was unloading. Once identified, provider shut down work and began clean up operations. Truck was loaded to 120 bbls before starting to offload, when spill was caught truck had 50 bbls remaining. 41 bbls was pumped into tank. Spill size was 29 bbls. All of spill was within containment and vacuumed back up. Containment was pressure washed. Root cause: Lease operator left valve open while pumping out recirc line. Remediation: Vac truck was on location at the time of spill. Oil was picked up immediately. Gang was called to pressure wash containment.
