An area of approximately 20 feet long and 10 feet wide was impacted by the released fluids. No washes/waterways were affected. The meter tube was isolated, depressurized, locked and tagged out. Enterprise began remediation on December 23, 2020 and determined the release reportable per NMOC regulation on December 28, 2020 due to the volume of impacted soil. A third party corrective action report will be submitted with the "Final C-141."
