The pump jack kept running and caused a leak as the wellhead packing. The affected area was around the wellhead with an approx. measurement of 6'x9'. Jicarilla requested LOGOS to remediate around the wellhead due to historic staining. As the roustabout crew cleaned the wellhead area, LOGOS had 30 yards of contaminated soil removed which caused this to be more than 5bbls.
