The surface owner (Jicarilla) requested to remove the separator to clean historic staining. As Kelley Services removed the staining, >20 yards was hauled off and disposed at Envirotech. The release was reported to NMOCD, per the calculations that if 12 yards fill a dump truck this equals 5bbls which then became reportable.
