The leak was confirmed and the pipeline was isolated, depressurized, locked out and tagged out. No fluids were released on the ground nor subsurface surface. No washes were affected. Enterprise determined this release reportable per NMOCD regulation on February 23, 2021 by the calculated volume of gas that was released. A calculated amount of 528 MCF was released. Soil samples were collected at the time of repairs. The sample results confirmed that there were no subsurface impacts.
