The relief valve popped off and sprayed crude oil from the separator and across the pad as shown. A backhoe was nearby and scraped up 48 yards of crude oil impacted soil that will be sent to proper disposal. Due to the low ambient temperature, the crude oil had solidified on top of the soil and soaking was minimal. Closure sampling will be conducted in the area of the release.
