Cause of Release: Corrosion

A 1/4" carbon steel pipe nipple coming off the water dump on the heater treater had corroded off the water dump resulting in a 110 barrel produced water spill into lined containment. A vacuum transport was dispatched to location and the spill was recovered in its entirety. The spill volume was verified via recovered fluid from the vacuum tanker. The heater treater has been bypassed and taken out of service so a thorough inspection of components can be completed. The recovered fluid was transferred into a production tank on location. The containment will be washed and a liner inspection scheduled.


