Once the source was isolated it was determined that the failure was the result of washed out threads on the 3/4" nipple of the victaulic wye strainer. This failure resulted in the release of approx. 45.33 bbl. of produced water inside of the containment, approx. 1.14 bbl. of which flowed into the pasture/SLO ROW from an apparent liner/containment failure. All standing fluid was recovered from the containment immediately to facilitate the identification of the failure
