There was a bull plug in the main 3-inch connection, but the ½ inch bleeder valve inside the environmental catch pot was open. The ETC LACT divert valve malfunctioned, causing the oil divert tank to fill up, which had the circulation line open on the back of the tank causing the oil to reach the level on the environmental catch pot and spill out onto the ground. Total released 101 barrels of crude oil outside of containment, and recovered 60 barrels of oil. An environmental company will handle remediation. |
