A vacuum truck was dispatched to remove all freestanding fluids. A 48 hour advanced liner notification was sent to the NMOCD District 1 office via email on 10/06/2021. The liner was visually inspected by an experienced and trained inspector in pad operations and visual liner inspections on 10/11/2021. 
