Steps taken to limit the duration and magnitude of vent or flare	Tap Rock saw a higher than normal flare volume due to downtime on of a VRU unit on location. The downtime increased low pressure flare. Tap Rock saw flare volumes due to flash gas coming off of the tanks and an excess amount of oxygen at the tank level. Tap Rock is working on the VRU and plans to bring on the wells slowly after the problem is corrected.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Tap Rock saw a higher than normal flare volume due to downtime on of a VRU unit on location. The downtime increased low pressure flare. Tap Rock saw flare volumes due to flash gas coming off of the tanks and an excess amount of oxygen at the tank level. Tap Rock is working on the VRU and plans to bring on the wells slowly after the problem is corrected. Tap Rock is analyzing this location and the equipment on location to verify the facility can capture all excess gas. If flaring continues Tap Rock will alter the facility by placing additional gas takeaway equipment.
