Please explain reason for why this event was beyond this operator's control	Third party, DCP, shut in our sales line unexpectedly due to high O2 in the line. Venting occurred due to depressurization of the sales line to purging the line to remove oxygen before start up. Intermittent venting: had to blow line down twice within 24hrs for same reason. First event was 17.5 hrs of venting and the second event was 4.5 hrs of venting.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. All wells feeding into this facility were shut in to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on ensuring sales gas was proper quality to reduce any further venting/ purging of the sales line.
