Initial investigation indicates the pipe leading to the loading arm was liquid-full and that heat tracing on the piping was on. Heat from the heat tracing caused LCO in the pipeline to expand and leak by the loading arm valve. The source of the leak was stopped and approximately 13bbls of LCO liquid was recovered from the ground. Mike Bratcher of OCD was notified via phone (voicemail) on Jan 21, 2022.
