There was a failure on the weld of the intake line off of water tank #3. The source was isolated and the tanks were pulled down. The failure resulted in the release of approx. 18.5 bbl. of produced water inside of the lined, secondary containment. Pressure washing is scheduled today to clean the impacted area, recover all standing fluid and prevent any slip, trips or falls prior to freezing temps at the end of the week.
