In a high pressure sales line compressors have to be running perfectly in order to gas into the line and prevent flaring. Total cum hours for this period is 48. This C-129 report covers flaring from 1/24-2/10
Steps taken to limit the duration and magnitude of vent or flare	Field team is still coming up with ways to curtail frequent flaring including replacing sales line this summer.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	As noted engineering team is trying to deal with high line pressure sales line but probably involves engaging tired party gas gatherer.
