After all tie ins were complete, two valves were inadvertently left shut allowing the VRT to fill and sending oil to the low pressure flare line resulting in a flare fire. A small pasture area near the flare caught fire burning ~0.5 acres. Personnel onsite immediately put out the fire. The Jal Fire Department was dispatched. The flare line will be flushed and flame arrestor will be cleaned before bringing wells back online.
