For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	This is a continuation of the event reported previously that occurred on 05/13. Gas was routed to flare to protect personnel and equipment when the facility lost compression on high fan vibration shutdown. The shutdown was caused by a piece of sheet metal that was obstructing the fan blades. The sheet metal came unsecured due to failed bolts. There is no recommended maintenance on bolts and their lifetime cannot be predicted.
Steps taken to limit the duration and magnitude of vent or flare	Gas was flared until the sheet metal could be reattached, the fan could be restarted, and compression could be restarted.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Once the sheet metal was reattached, the fan was restarted. Compression was restarted, normal operations resumed, and flaring ceased.
