Please explain reason for why this event was beyond this operator's control	The gas plant where this gas goes is operated by Durango Midstream. They have been having compressor problems for the last month, which causes our static pressure at the well to go up, thus sending some of the produced gas to flare. Our gatherer is Frontier Field Services, LLC. Not sure its their responsibility to notify us, but Durango's. Unfortunately, we didn't know there's an issue till we are on our well and seeing it go to flare.
Steps taken to limit the duration and magnitude of vent or flare	The flaring is intermittent, not full time. Since this is a downstream third party issue, there isn't much we can do to limit duration or magnitude short of shutting in the well.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Durango is working on their compressor problems.
