For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	The compressor experienced unexpected mechanical issues and needed repair which resulted in intermittent flaring.
Steps taken to limit the duration and magnitude of vent or flare	Chevron field personnel executed practicable measures to minimize emissions. After the compressor shutdown due to mechanical issues and repairs RAO cut back production on the wells resulting in intermittent flaring which lasted 2.4 hours cumulatively. Once the compressor was repaired and brought online flaring stopped on 6/27 at 12:20pm.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
