Steps taken to limit the duration and magnitude of vent or flare	Chevron field personnel executed practicable measures to minimize emissions. Crews were contacted to come out to the site to work on the tanks and adjust/calibrate vapor recovery units. Venting started at 6:30pm on 7/8/2022 and ended at 3:30pm on 7/10/2022.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas vented.
