Most of the spill was confined to the lined containment. Approximately 1.5 bbls did breach the containment and stayed on location. The spill was caused by a power loss at the SWD. All pumps going to the SWD were turned off to stop the spill. In addition, the inlets were closed to prevent new water entering the facility. Recovery trucks were called. Initially reported as 998.6 bbls released.
