Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. Maintenance was called out to replace the faulty pressure transmitter.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared. Field specialists contacted maintenance and the faulty pressure transmitter was replaced.
