Please explain reason for why this event was beyond this operator's control	Compressors experienced an unexpected malfunction when they shut down on high pressure caused by a vibration switch forcing more pressure to the other compressors. This resulted in flaring.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. Wells shut in, and compressors were restarted and brought back online as soon as possible ending the flaring.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
