Dear Mr. Maestas:

Transwestern Pipeline Company, LLC's (Transwestern) is notifying the New Mexico Environment Department of Hazardous Waste Bureau that the East Baker Thermal Oxidizer/SVE Unit located at the Roswell Compressor Station No. 9 (Site) has malfunctioned due to the degradation of the structural and electrical components integrity of the unit which has created an unsafe operating condition. Transwestern is currently in communication with thermal oxidizer equipment manufacturers to identify and acquire a replacement unit that will be like in kind. In the meantime, the West Baker Thermal Oxidizer SVE Unit is functional and will continue to operate at the site to ensure continued soil vapor extraction.

In accordance with Section IV.B.1 of the March 2013 Stipulated Order, Transwestern will submit a summary of remediation system repairs and maintenance when the system is not in operation for longer than 48 hours in the Annual Groundwater Monitoring Report (2022).
