The vessel was isolated and taken out of service until repairs are made. The impacted soils are being scraped up from the well pad and hauled to an approved disposal site. Any further remediation will take place in the coming weeks. The containment will be washed and a liner inspection scheduled. Spilled: 50 barrels (15 barrels oil + 35 barrels water) Recovered: 43 barrels (8 barrels oil + 35 barrels water)
