Tap Rock saw flare volumes due to flash gas coming off the tanks and an excess amount of oxygen at the tank level. The flash gas needs to be flared for safety purposes regarding to facility integrity and for those working on the facility. Tap Rock is analyzing this location and the equipment on location to verify the facility can capture all excess gas. If flaring continues Tap Rock will alter the facility by placing additional gas takeaway equipment.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	HP flare volume to keep flare pilot lit. Tap Rock saw flare volumes due to flash gas coming off the tanks and an excess amount of oxygen at the tank level. The flash gas needs to be flared for safety purposes regarding to facility integrity and for those working on the facility. Tap Rock is analyzing this location and the equipment on location to verify the facility can capture all excess gas. If flaring continues Tap Rock will alter the facility by placing additional gas takeaway equipment.
