Night operator arrived on location to a valve on the tank recirculating pump left open, which is not normal practice. This resulted in a very thin layer of produced water being released into the lined, secondary containment, totaling just over 11 bbl. The valve was immediately closed and the containment is scheduled to be pressure washed, at which time, all fluid will be recovered.
