At the Cottonwood #2 SWD an Inlet control valve was set to manual operating position bypassing the high tank level shut off function. An H Pump went down on low level and did not restart on high level, an alarm sounded and was responded to, one of the inlet tanks ran over into the secondary containment, with some of the Produced Water escaping secondary containment.
