For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	Silverback could not have anticipated the current event which was caused by high pressure in Enterprise's pipeline. Enterprise has a back pressure valve installed on their sales meter run that closes and diverts our gas to flare when their pressure increases above a set amount.
Steps taken to limit the duration and magnitude of vent or flare	The pressure on Enterprise's pipeline system is controlled by Enterprise and Enterprise compression operations. If Enterprise does not adequately compress the volume of gas flowing into their system, the line pressure increases. Enterprise back pressure valve starts closing at a preset line pressure and our gas gets diverted to flare. The only action we could take would be to choke back or shut in our wells. We have seen shutting in our wells to be detrimental to production levels and only shut wells in if absolutely necessary. We contacted Enterprise and notified them of our high line pressure.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Enterprise needs to install more compression so back up compression is available
