For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	Flared due to malfunction on inlet of compressor.
Steps taken to limit the duration and magnitude of vent or flare	Flare occurred while bringing the 226 compressor back online with the new compressor. The NOVA compressor suction line filter was plugged and crushed, which prevented heater treater gas from entering compressor suction line. The heater treater back pressure was increased from 70 psi to 80 psi, which prevented flaring until 80 psi was reached.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The cause was not correctly determined at this point. We believed it to be an issue with the heater treater ack pressure valve or the equalizing line between the two heater treaters. Slight changes were made and the flare decreased. The next day it was discovered that the compressor suction filter was crushed and prevented heater treater gas from being pushed into the suction of the compressor (i.e. compressor suction was at 100 psi and HT pressure was at 80 psi). The filter was fixed on the 4th.
