| Steps taken to limit the duration and magnitude of vent or flare                                                                 | The pressure on DCP's pipeline system is controlled by DCP and DCP's compression operations. If DCP does not adequately compress the volume of gas flowing into their system, the line pressure increases. DCP's back pressure valve starts closing at a preset line pressure and our gas gets diverted to flare. The only action we could take would be to choke back or shut in our wells. We have seen shutting in our wells to be detrimental to production levels and only shut wells in if absolutely necessary. We contacted DCP and notified them of our high line pressure. |
