At compressor stations, pressure was lowered through flaring to prevent overpressurization of pipe which can lead to pipeline ruptures.
Steps taken to limit the duration and magnitude of vent or flare	Restarted units and resumed normal operations as soon as power was restored.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Equipment shutdowns due to high suction pressure occurs to prevent damage to equipment. Reoccurrence is likely when inlet is pressured up beyond equipment tolerance level.
