Please explain reason for why this event was beyond this operator's control	Durango had us shut in our lines to them for maintenance, and then later DCP requested us to shut in three batteries due to maintenance. Durango had not come back on line so we had no avenue to take the gas to.
Steps taken to limit the duration and magnitude of vent or flare	due to both vendors being down for maintenance we adjusted pressure release valves to keep facility integrity which caused the facility to flare due to excessive pressure
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	We have plumbed our facilities to both regional midstream providers but in this case they were both down at the same time conducting maintenance
