As soon as the release was found during a routine inspection on 5/8/2023, the operator closed the valve to stop the leak. After stopping the leak, a trash-pump was used to recover approximately 5 bbls of standing produced water into the pit tank on location. 5.2 bbl produced water could not be recovered and soaked into the pad surface. The spilled fluids remained on the pad surface.
