For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	Gas was vented to atmosphere when a leak was discovered on Targa's 10 in steel gathering pipeline. The leak was due to corrosion on the pipeline. The pipeline is underground, and the corrosion was not visible. The first sign of corrosion on an underground pipeline is a leak. Furthermore, the only way to make repairs is to depressurize the corroded section of pipeline to atmosphere. This event was beyond Targa's control.
Steps taken to limit the duration and magnitude of vent or flare	The corroded section of pipeline was isolated and depressurized to atmosphere. Once the section of pipeline was fully depressurized, the emission event ended.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The corroded section of pipeline was replaced. Once the new section of pipeline was verified to be safe to operate, the pipeline was returned to normal service.
