Due to high gusts on 9/11/2023, the wind blew over stairs at the 3 phase and fell on the oil outlet piping causing a 2" nipple to break at the threads and the fitting. Oil mixed in with released produced water and rain water from the storm. The well was shut in and the compressor and unit were powered of and blown down. It is estimated that 10 bbls of oil and 124 bbls of water (including accumulated rain water) are in the lined containment. Will update the recovered volumes when the truck finishes cleanup.
