At approximately 11:30 am operations was onsite to prove the LACT. During the proving operation, the hose ruptured causing the crude oil release. Based on operational data ~29 bbls of crude oil was lost to the ground. Once the issue was identified the valve was closed completely ending the release. The affected area is completely contained within the location. Land based response actions were implemented immediately. These activities include scrapping up the affected soil/caliche and placing it on tarping in a secure location at the site. The affected area has been completely secured at this point and there are no longer any free liquids in the affected area.
