#### Cause of Release: Equipment Failure

We had a minor reportable release at the Crawford 27-26 Fee Facility. The Control Room received an alarm low heater pressure and immediately shut in the wells until personnel could investigate. Once on location, we found a heater treater firetube gasket failed, releasing a total of 11 barrels oil into the lined containment and onto the well pad. All fluids were recovered from the containment. Impacted soils will be remediated in the coming weeks.

Released: 11 barrels water (3 barrels inside containment + 8 barrels onto well pad)


