Safety protocols while purging oxygen were followed, and flaring was minimized for this event, as each well flowline and flowback equipment were conducted one at a time to ensure safety for all personnel, equipment, and environment.

In this case, as a necessary measure to prevent future issues with Targa and their O2 gas intake sensors, Oxy field personnel purged the O2 from the several well flowlines and wellhead flowback equipment to the facility. Due to sale quality concerns, we had to purge the Oxygen. Safety protocols while purging oxygen were followed, and flaring was minimized for this event, as each well flowline and flowback equipment were conducted one at a time to ensure safety for all personnel, equipment, and environment.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is limited in its corrective actions to eliminate the cause and potential reoccurrence of O2 accidentally pushed into the sales gas service system pipeline. OXY makes every effort to control and minimize emissions as much as possible.
