Reason why this event was beyond Operator's control:

The emissions were caused by the sudden, unavoidable breakdown of equipment or process that was beyond the owner/operator's control and did not stem from activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and maintenance practices. Internal Oxy procedures ensure that upon a sudden and unexpected flaring event, production techs are promptly notified, and are instructed to assess the issue as soon as possible to take prompt corrective action and minimize emissions. In this case, gas had to be flared rather than be compressed when one of the compressors went down on a faulty High Scrubber level alarm due to a loose wire. The Compressor going down caused excessive gas to build up in the sales line from the CGL to the Facility and caused the VRUs to shut down on High discharge pressure and gas sent to the flare out of necessity to protect personnel and equipment as a safeguard until the dump valve could be reset and compressor could be restarted and returned to normal maximized operation.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route all stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. The flare at this facility has a 98% combustion efficiency to lessen emissions as much as possible. In this case, gas had to be flared rather than be compressed when one of the compressors went down on a faulty High Scrubber level alarm due to a loose wire. The Compressor going down caused excessive gas to build up in the sales line from the CGL to the Facility and caused the VRUs to shut down on High discharge pressure and gas sent to the flare. Oxy field personnel worked diligently and efficiently to track down and locate the wiring fault. Once the repair was completed the compressor was put in service and the VRUs were then able be put back in service due to the lower facility pressure to stop flaring.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is limited in its corrective actions to eliminate the cause and potential reoccurrence of a malfunctioning VRU, as notwithstanding proper VRU, design and operation, whether low- or high-pressure, various forms of mechanical or technical issues can be sudden, reasonably unforeseeable and unexpected which can cause equipment malfunctions to occur without warning or advance notice. OXY makes every effort to control and minimize emissions as much as possible during these circumstances. The limited actions that Oxy can do in this circumstance is to immediately investigate the failure and find the issues return the equipment to normal operation to have the issue resolved in a timely manner and continue monitoring the equipment until its repair and restoration to normal operations is complete.
