1. Reason why this event was beyond Operator's control:

The emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable interruption, restriction or complete shut-in of a gas pipeline by a third-party pipeline operator, which impacted Oxy's ability to send gas to a third-party gas pipeline. This interruption, restriction or complete shut-in of the gas pipeline by a third-party pipeline operator is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. In this case, Targa's associated gas plant was having issues with their equipment. Until Targa's associated gas plant was able to resolve their downstream facility equipment issues, Oxy was unable to push its gas into their gas sales service pipeline as there were immediate restrictions of the gas sales service pipeline to Oxy. No advance warning of any kind was provided to Oxy personnel from Targa personnel regarding issues with their associated gas plant equipment issues. This incident was completely out of Oxy's control to prevent from happening yet OXY made every effort to control and minimize emissions as much as possible during this event.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route all stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, as the part of the overall process or steps to take to limit duration and magnitude of flaring. Oxy personnel are in the field 24/7 and can physically see when we are flaring which in turn are communicated to additional Oxy field personnel. In this case, Targa's associated gas plant was having issues with their equipment and until Targa's associated gas plant was able to resolve their downstream facility equipment issues, Oxy was unable to push its gas into their gas sales service pipeline as there were restrictions and a shut-in of the gas sales service pipeline to Oxy. Oxy field personnel began to shut in wells as soon as flaring was triggered. No advance warning of any kind was provided to Oxy personnel from Targa personnel regarding issues with their associated gas plant equipment issues. This incident was completely out of Oxy's control to prevent from happening yet OXY made every effort to control and minimize emissions as much as possible during this event.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is limited in its corrective actions to eliminate the cause and potential reoccurrence of a Targa gas flow pipeline restriction or shut in, as this control issue is downstream of Oxy's custody transfer point and out of Oxy's control to avoid or prevent from happening or reoccurring. Targa's downstream facility or gas plant issues will re-occur from time to time, which in turn, directly impacts Oxy's ability to send gas to them. When Targa's downstream facility or gas plant has equipment has issues or greatly struggles to handle the volume of gas being sent to them by Oxy, Targa then restricts or cuts off Oxy's ability to send gas, which then prompts Oxy to route its stranded gas not pushed into the Targa gas pipeline, to suddenly and unexpectedly flare. OXY makes every effort to control and minimize emissions as much as possible during these circumstances. The limited actions that Oxy can do in this circumstance is to shut in its wells in a swift and diligent manner, to cease flaring.
