1. Reason why this event was beyond Operator's control:

This emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable breakdown of equipment or process that was beyond the owner/operator's control and did not stem from activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. Oxy engages in respectable and good facility operation practices while also maintaining its continuous facility equipment preventative maintenance program. In this case, there were sudden and unexpected multiple compression equipment malfunctions because of a frozen fuel skid, which in turn, then prompted high field pressure to occur several times within a 24-hr period, which then triggered brief instances of intermittent flaring to occur. This event is out of OXY's control yet OXY made every effort to control and minimize emissions as much as possible.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. The flare at this facility has a 98% combustion efficiency to lessen emissions as much as possible. In this case, there were sudden and unexpected multiple compression equipment malfunctions because of a frozen fuel skid, which in turn, then prompted high field pressure to occur several times within a 24-hr period, which then triggered brief instances of intermittent flaring to occur. In each instance that flaring occurred, the facility's well optimizer adjusted injection rates and field personnel manually shut-in wells to mitigate and subsequently cease flaring. Notwithstanding proper gas compressor design and operation, various forms of mechanical or technical issues can be sudden, reasonably unforeseeable and unexpected which can cause compressor unit malfunctions to occur without warning or advance notice. Compressor engines are designed to operate in a precise manner and when malfunctions occur, it disrupts the compression unit's operating manner and robs the compression engine of power, thus, causing an automatic shutdown of the unit.
